Proximity to the school with those living closest to the school having priority calculated by: For admissions purposes the LA uses data provided by Ordnance Survey (OS) to measure straight line distances. The OS data plots the coordinates of each individual property (the home address) which are referred to as address points. The definition of the home address is as described on pages 12-13 in <u>Essex Admissions Booklet</u> .
